# **2018 - 2019 Highlights**

The CAC team continues to make progress on the strategic objectives laid out in our 2017 plan, as follows:

# Keep pace with changing older adult needs

CAC continues to expand exercise and wellness offerings that are evidence-based, while maintaining the very popular existing line dancing class. In 2018-2019, staff continued with Walk with Ease and added a periodic Matter of Balance class as well as a year-long Diabetes Prevention class. Clackamas County staff also offered the Living Well with Chronic Conditions series.

We regularly offered more active recreational trips to include exploring and walking outdoors when weather permitted, and tried out a variety of new dining experiences. Finally, the nutrition team continues to offer a lighter meal for lunch once a week, to accommodate those who prefer to eat less at lunchtime.

# Raise our profile in the community

CAC now has a professionally developed, updated brochure to accompany the new website. Center activities are regularly posted to Facebook and shared in the Canby Herald. Finally, CAC is working to raise public awareness of its activities and the older adult population more generally through staff participation in the Canby Chamber of Commerce's Diversity and Inclusion committee.

# <u>Upgrade the physical facility to accommodate changing older</u> adult interests

New chairs were ordered and received for the dining room; chairs in the TV and lounge area were replaced, and new, space-saving tables were purchased for the small meeting room allowing for more agility in use of that space.

# **Grow and diversify sources of CAC support**

CAC's funding base is stable and reliable. 2018-2019 saw several temporary rate increases for Older Americans Act (OAA) funding, allowing CAC to reduce its draw on investment funds for the fiscal year.

CAC also benefited from two bequests during 2018-2019, and received notification of pending bequests from at least two additional estates, still to be settled. Finally, the Annual Appeal outperformed expectations for yet another year.

A special note of thanks to the many volunteers who work tirelessly in the kitchen, at the front desk, in the classroom, on the road and elsewhere – we couldn't do what we do without them.
